In terms of Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with related circulars and notifications, following matter was approved by the Board of Directors in its meeting held today, i.e. January 14, 2026:

1. Increase in the Authorized Share Capital of the Company from ₹ 45,00,00,000 (Rupees Forty Five Crores only) divided into 4,50,00,000 (Four Crores and Fifty Lakhs) equity shares of ₹ 10 (Rupees Ten only) each to ₹ 65,00,00,000 (Rupees Sixty Five Crores only) divided into 6,50,00,000 (Six Crores and Fifty Lakhs) equity shares of ₹ 10 (Rupees Ten only) each, by creation of additional ₹ 20,00,00,000 (Rupees Twenty Crores only) divided into 2,00,00,000 (Two Crores) equity shares of ₹ 10 (Rupees Ten only) each and consequent amendment in the Capital Clause (Clause V) of Memorandum of Association of the Company, subject to approval of the shareholders of the Company through ensuing Postal Ballot.
2. Appointment of Mr. Ashok Uttam Chandanshive (DIN:11038160) as an Additional Non-Executive Independent Director of the Company and to recommend the members to regularize his appointment through ensuing Postal Ballot.
3. Approved the Draft Notice of the Postal Ballot for seeking consent of the members of the Company for the proposed resolution for increase of authorized share capital and appointment of Mr. Ashok Uttam Chandanshive (DIN:11038160) as an Additional Non-Executive Independent Director of the Company.
4. Appointment of Ms. Neeta H. Desai (Membership No. 3262, COP No. 4741) of M/s ND & Associates, Practicing Company Secretaries as the scrutinizer (“Scrutinizer”) for conducting the ensuing Postal Ballot through e-voting process in a fair and transparent manner.
